#### 1. Overview

The Apprenticeship and Trade Certification Act, 1999 created the Saskatchewan Apprenticeship and Trade Certification Commission (SATCC). The SATCC has authority to manage the Apprenticeship and Trade Certification system in Saskatchewan. The Act also gives the SATCC the authority to make regulations to ensure the efficient and effective operation of the apprenticeship system to meet the needs of industry in a timely manner. The Act sets out the SATCC's accountability to government and industry.

The SATCC features an industry-led governance structure with revenue-generating authority to ensure that program services and training are timely and effective. Saskatchewan Industry selects twelve of the twenty SATCC Board members equally from employers and employees. The Board also includes eight representatives from the Government of Saskatchewan, training providers, under-represented and equity groups. The Minister of Advanced Education, Employment and Labour (AEEL) is responsible for the SATCC.

#### **SATCC Vision**

A skilled and representative trades workforce, industry trained and certified.

#### **SATCC Mandate**

To develop and execute a relevant, accessible and responsive apprenticeship training and certification system to meet the needs of employers, apprentices, journeypersons and tradespersons. This mandate is based on *The Apprenticeship and Trade Certification Act, 1999* and *The Apprenticeship and Trade Certification Regulations*.

#### **Operational Context**


Apprenticeship and trade certification is a demand side training program, serving the needs of apprentices who are employed and registered in a skilled trade and the employers who sponsor them. Apprenticeship differs from supply side certificate and diploma programs offered in post-secondary institutions which prepare graduates for entry to the workforce. Apprentices are employed, fully engaged in their chosen careers and contributing significantly to Saskatchewan's prosperous economy.

The SATCC plays a key role in the province's labour market development by providing a platform for workplace training and experiential learning, technical training, and industry certification in 47 skilled trades and 23 sub-trades.

The SATCC interfaces with the Saskatchewan post-secondary education system through the development of training standards and the delivery of apprenticeship technical training.

The number of apprentices in the system grew from 5436 on June 30, 2005 to 9000 on June 30, 2010 (forecast); with an average of 872 apprentices completing their apprenticeships annually. This growth since 2005 has created high demand for

apprenticeship technical training. The SATCC continues to register apprentices at a very high rate and purchase seats at a volume not anticipated 5 years ago.



The Construction Sector Council (CSC) assessment of Saskatchewan's construction labour demands from 2009 to 2017 "reveals tight [labour] markets, strong job prospects and labour market challenges".1

The report goes on to state, "Throughout the scenario, other regions will also experience high demand periods, which will create strong competition for qualified workers. It will be important for Saskatchewan to maintain a skilled workforce in order to meet demands."2

The Mining Industry Human Resource Council, in its report to the Saskatchewan Mining Association, indicates that the mining sector in Saskatchewan will require an additional 18,000 workers in the next 10 years, including over 4,000 skilled tradespeople<sup>3</sup>.

In May 2009, "Right People, Right Place, Right Time – Saskatchewan's Labour Market Strategy" was released. It confirmed that an important strategy to ensure an adequate supply of skilled labour for the provincial economy is the engagement of the large Aboriginal working age population and skilled immigrant labour.

The Ministry of Advanced Education, Employment and Labour (AEEL) 2010-2011 budget plan sets out the Ministry's key goals and actions. In order to support the provincial goal of sustained economic growth for the benefit of Saskatchewan people, ensuring the economy is ready for growth and positioning Saskatchewan to meet the challenges of economic and population growth and development, AEEL will focus on the following areas:

- Ensure a skilled workforce to meet existing and future labour market demand
- Ensure that Saskatchewan's post-secondary system is characterized by: excellence, innovation, inclusion and accountability, and is responsive to the needs of learners and Saskatchewan's labour market
- Increase post-secondary education levels and labour market participation of First Nations and Métis peoples to meet existing and future labour market demand
- Support increased attraction and retention of newcomers to Saskatchewan

Additionally, the 2010-2011 budget plan seeks to secure Saskatchewan as a safe place to live and raise a family where people are confident in their future, ensuring the people of Saskatchewan benefit from the growing economy. An outcome in the budget plan of particular relevance to apprenticeship training and trade certification is:

Foster productive, safe and competitive workplaces

SATCC's 2010-2011 business plan aligns with the AEEL goals and areas of focus. These goals and outcomes are intrinsic to the apprenticeship and trade certification program.

The 2010-2011 SATCC Business Plan is designed to ensure that the SATCC continues to meet the needs of industry and support the growth of the provincial economy.

To continue meeting demands of the provincial labour market to supply a skilled workforce and support the growth of Saskatchewan's economy, the SATCC must find ways to train increased numbers of skilled tradespeople.

The SATCC prioritizes funding and staff resources, not only to meet the increased technical training needs for apprentices already registered, but also for specific initiatives to increase efficiencies, improve services, and promote the participation of youth, Aboriginal and foreign trained workers in skilled trades and apprenticeship training.

The SATCC core operating activities are impacted by key factors, such as the number of newly registered apprentices. The 2010-2011 business plan estimates for the key factors and operation activities, including the previous fiscal year comparators are provided in the following chart.

#### **Risk Analysis**

The SATCC identified the following as potential risks to the 2010-2011 Business Plan.

#### Immediate Risks

 Impact of growth in apprenticeship registrations – the demand for new and existing apprentices will continue at a level similar to the 2009-2010 year.

#### Short Term Risks

 Apprenticeship technical training capacity – technical training is contracted to institutions (Saskatchewan Institute of Applied Science and Technology {SIAST} and others) for delivery. Institutions must have the capacity, facilities and qualified instructors to deliver technical training to apprentices when numbers increase; and the ability to retain both HR and physical plant capacity when numbers decline.

#### Medium Term Risks

- Demand for technical training and sufficient financial resources –the level of provincial funding for the SATCC impacts: a) the amount of technical training which can be purchased; and, b) SATCC operations. Technical training costs continue to increase as does the demand for technical training. The SATCC has met the 10% revenue generation goal in the years ended 2005 to 2008, but this percentage declined to 9.2% in 2009 and will not be able to attain 10% at the current level of client fees.
- Attracting, training, motivating and retaining staff The number of staff (both in-scope and out-of-scope) eligible or becoming eligible for retirement continues to increase. Vacant positions may be advertised multiple times and not attract any qualified candidates. The challenge for the SATCC is to present itself as an employer of choice by providing a challenging, interesting workplace within a supportive team atmosphere.

#### Long Term Risks

Employer commitment to apprenticeship and trade certification – employers who register apprentices demonstrate their commitment to train and certify to national industry standards. The challenge is to engage employers to participate in the apprenticeship program as opposed to hiring journeypersons from other employers. The SATCC continues to work with employers through workplace consultations to promote apprenticeship and the mobility of skilled labour as the best option for the industry.

#### 3. 2010 - 2011 Budget

#### Overview

The largest component of the SATCC's operating expenses is apprenticeship technical training, at approximately 75% of expenditures. Technical training costs for the 2010-2011 are based on the following assumptions:

- new client registrations and technical training attendance based on the past three years;
- a 2% increase on the salary portion of SIAST technical training costs (1.5% 2009-2010); and
- a 3% inflationary increase for all other technical trainers.

The total number of technical training seats is estimated to increase 3% in the next year, with 475 courses being offered and 5869 apprenticeship technical training seats available. Salary and material cost increases experienced by the training providers will also contribute to higher costs. The overall 2010-2011 technical training costs are forecast to be 8% higher than the previous year's budget.

The SATCC salaries represent approximately 16% of operating expenses. This budget includes salary increases of 2% in 2010-2011 (1.5% in 2009-2010). In the 2009-2010 budget, a vacancy rate of 10% was applied. For 2010-2011, a 15% vacancy rate is budgeted. The 2010-2011 salary budget includes one additional full time position for an individual with expertise in writing/marketing to assist in and support the SATCC communications, promotion and marketing area. The function is currently performed by one staff member. This will bring the SATCC's total complement to 73.54 full time equivalent (FTE) positions.

The 2010-2011 provincial budget provides the SATCC with a total grant of \$19,682,000, comprised of \$17,333,000 which was provided in the 2009-2010 budget, one time funding of \$1,800,000 and \$149,000 for collective agreement costs. Other budgeted revenues include:

- Revenue generation from client fees (tuition fees based on available technical training seats) - \$2,034,800
- ATA administrative fees \$180.000
- Centennial Merit Scholarship grant \$25,000
- Other revenue \$63,000

The SATCC is required to maintain a minimum cash surplus (per Commission Board Policy) of approximately \$400,000. SATCC is required to closely monitor revenues and expenditures and must manage operational and training demands within the resources available.

The SATCC budgeted expenditures for 2010-2011 include:

- Technical training costs \$16,636,800
- Salaries \$3,586,000

- Travel costs \$429,400
- Office supplies \$65,000
- Computer hardware and software \$17,800
- Office repairs and building improvements \$500,000
- Office equipment and furniture \$31,700

#### **Regina Office Environment Improvements**

In the 2009 – 2010 fiscal year, the SATCC initiated office environment improvements to its head office at 2140 Hamilton Street, Regina. These improvements were required to address: identified OH&S concerns; security concerns; inadequate electrical, mechanical and communication systems; structural inadequacies; and functionality issues. The Phase 1 cost was \$550,000. In the 2010 – 2011 fiscal year, the SATCC proposes to complete Phase 2 of the office environment improvements to the Regina office at an estimated cost of \$400,000.

Historically, the apprenticeship agency has not requested capital improvement funding. This proposal is a "one-time" initiative to address structural, mechanical (heating/ventilation), OH&S, security and space usage issues.

Apprenticeship technical training and operational funds will not be used for office environment improvements. SATCC, within its enabling Act, has the right to raise and retain revenue. Over the years, a surplus has been retained and will be used to fund the improvements.

In the 1990s, the apprenticeship branch was moved by Saskatchewan Government Services from an inadequate and undersized location at London Life Place to the Walter Scott Building. The space at the Walter Scott facility was roughly 1/3 smaller than that previously occupied, resulting in significant operational issues. After the SATCC was created in 1999, one of the first initiatives was to resolve the unacceptable space issue by leasing a portion of the current facility at 2140 Hamilton Street in 2001. The space, although adequate at the time, had not been functionally designed for apprenticeship operations and was partially occupied by other tenants.

Over time, the number of clients served annually has increased from 6,820 in 2004-2005 to approximately 10,960 in 2008-2009. In response to the escalating demand for services, the SATCC acquired the lease for the entire Regina office building in 2007. The lease is secured until 2017 and the negotiated lease rate is significantly lower than other similar facilities in Regina (\$86 versus \$151 to \$161 per square metre for 2010-2011) with capital improvements the responsibility of SATCC. These terms allow SATCC to manage the timing and extent of capital improvements made. The lease rate is half the rate charged in Saskatoon, and one-third the rate charged by Government Services for the SATCC office in Yorkton. The age of the building, unsuitability of renovations by previous tenants, and outdated infrastructure that required immediate attention, resulted in much wasted space and diminished functionality.

Phase 1 of the office environment improvement has been completed. The necessary improvements included adding structural elements to the main floor of the building, which was no longer able to support the weight of the files; re-design and replacement of much of the building's outdated electrical system; re-design and replacement of the heating and ventilation system, required to address occupational health and safety issues and heat/cool distribution issues; and repairs to interior partition walls, resulting in an increase in office space from 21 to 28 work stations, and the addition of 3 functional meeting rooms in previously unusable space. The front facing walls of the offices are a modular component, a DIRTT Wall system, valued at approximately \$250,000 and will remain the property of the SATCC.

Phase 2 of the office environment improvements is slated for the second floor which remains in its original state. These improvements include additional security measures for high stakes national certification examinations, reconfiguring interior partitions to significantly increase space usage and function; and connecting the second floor to the renewed HVAC system installed during Phase 1. The current second floor HVAC configuration will resolve the issues of widely varying heat and cold conditions, and needs to be completed as soon as possible.

The SATCC has a long term lease on the building, with 7 years remaining. This capital expense is considered to be a one-time occurrence; no future capital requests are anticipated for any of the SATCC's office locations. The entire cost of the office environment improvement is estimated at \$950,000. If amortized over the remaining term of the lease, the lease rate would be \$186 per square metre which still compares favourably with most lease rates. The primary advantage in improving the office environment is that the space will now be purpose built specifically for the efficient operations of the SATCC and enhance service for all apprenticeship and trade certification clients throughout Saskatchewan.

#### **Revenue Generation Proposal**

The provincial grant for 2010-2011 includes \$1.8M in one time Labour Market Development Agreement Stimulus funding. Consideration has been given to future sources of revenue, leading to the following proposal. Client fees currently provide approximately \$2M in revenue to the SATCC. These fees are primarily derived from tuition for apprentice technical training, currently set at \$30 per week (on average, annual tuition for an apprentice is \$240).

Tuition fees for apprentice training were first introduced in 2002-2003 at \$15 per week for an average annual cost of \$120 for an apprentice taking technical training. Tuition fees increased to \$30 per week in 2004-2005 and have remained at this level for the last 5 years.

It is proposed that there be no increase in tuition for 2010-2011, followed by a progressive plan to increase tuition by \$15 per week in each of the following three years. This would result in the following tuition fee schedule:

- 2010-2011 \$30/week (average annual course cost \$240);

  Tuition revenue based on 5,870 seats is approximately \$1.4M
- 2011-2012 \$45/week (average annual course cost \$360);
  Projected tuition revenue\* is approximately \$2.1M
- 2012-2013 \$60/week (average annual course cost \$480);
  Projected tuition revenue\* is approximately \$2.8M
- **2013-2014** \$75/week (average annual course cost \$600); Projected increase in tuition revenue\* is \$3.5M

The SATCC Board of Directors, in consultation with AEEL officials, will develop a policy direction on how tuition rates will be established.

<sup>\*</sup> Projected tuition revenues are calculated using the number of technical training seats budgeted for 2010-2011.
