#### **SATCC Overview**

The Apprenticeship and Trade Certification Act, 1999 provides the Saskatchewan Apprenticeship and Trade Certification Commission (SATCC) with the mandate to manage the apprenticeship and trade certification system in Saskatchewan. The Act gives the SATCC the authority to make regulations to ensure the efficient and effective operation of the apprenticeship system to meet the needs of industry in a timely manner. It also sets out the SATCC's accountability to government and industry.

The Minister of Advanced Education, Employment and Immigration is responsible for the SATCC which features an industry-led governance structure with revenue-generating authority to ensure that programs, services and training are timely and effective. Saskatchewan industry selects twelve of the twenty SATCC Board members, six employer representatives and six employee representatives. The Board also includes representation from the Government of Saskatchewan, training providers, under-represented and equity groups. The chair of the board is elected annually by the SATCC Board members.

#### **Vision**

A skilled and representative trades workforce, industry trained and certified.

#### **Mandate**

To develop and execute a relevant, accessible and responsive apprenticeship training and certification system to meet the needs of employers, apprentices, journeypersons and tradespersons.


#### **Operational Context**

Apprenticeship and trade certification is a demand side, labour market training program, serving the needs of apprentices who are employed and registered in a skilled trade and the employers who sponsor them. Apprenticeship differs from supply side certificate and diploma training programs offered in post-secondary institutions which generally prepare graduates for entry to the workforce. Each and every apprentice is employed from the beginning of the apprenticeship, fully engaged in their chosen careers and contributing significantly, both personally and professionally, to Saskatchewan's prosperous economy.

The SATCC plays a key role in the province's labour market development through its province-wide coordination of workplace training and experiential learning, technical training, and industry certification for 47 skilled trades and 23 sub-trades

The SATCC cooperates with Saskatchewan technical training providers on the development of training standards and the delivery of apprenticeship technical training and tradesperson upgrader training.

The number of registered apprentices on June 30, 2007 was 6,779. By June 30, 2012 the number of registered apprentices is projected to be 10,070, an increase of 48.8% in 5 years. The average annual number of apprentices completing their apprenticeships between 2007 and 2012 is 1,136 (based on a forecast figure for 2012). The remarkable growth since 2007 has created greater demands for apprenticeship technical training. The SATCC continues to register apprentices at a very high rate and requires training seats at a volume not anticipated even three years ago.



Over the last 5 years, Saskatchewan's rate of growth in new apprentice registrations and total number of registered apprentices has outpaced both Alberta and British

The Construction Sector Council (CSC) 2012 forecast for Saskatchewan's construction labour demands between 2012 and 2020 "describes the peak of a steep climb over 10 years of growth. Since 2001, industry employment has expanded by 70 per cent. These gains surpass the remarkable construction growth in Alberta and British Columbia over the same period. All this growth has placed a heavy burden on labour markets, and recruiting at times, has been difficult."1

The construction labour requirements are forecast to continue growing, reaching a new peak in 2013, and then sustain close to the record high employment levels for the remainder of the forecast period.<sup>2</sup>

In a report released in March 2012, the Conference Board of Canada emphasizes the ongoing strength of Saskatchewan's economy by forecasting a growth rate in real GDP of 5.2 percent in 2011. This is the highest growth rate among all provinces for last year. In 2012 growth will slow to 2.6 percent; but is expected to accelerate to 3.5 percent in 2012. <sup>3</sup>

The Ministry of Advanced Education, Employment and Immigration (AEEI) projects an annual overall growth rate in employment of 0.9 percent from 2009 to 2014.4 Employment in the mining sector alone over this period could expand by 3.0 percent a vear.5

In January 2012, Enterprise Saskatchewan compared the economic forecasts of seven private-sector firms for the upcoming year. The average GDP growth rate of these forecasts for 2012 is 3.0 percent. The Canada-wide average of all jurisdictions for this year is forecast to be only 2.2 percent. Two of the seven forecasters ranked Saskatchewan in first place among all Canadian jurisdictions for GDP growth this year.<sup>6</sup>

Given the forecast economic growth in the construction, mining and energy sectors, it can be expected the demand for skilled tradespeople will continue to be as robust as it has been in the past few years.

The Ministry of AEEI 2012-2013 budget sets out the Ministry's key goals and actions. AEEI will focus on the following areas in order to support the provincial goal of sustaining growth and opportunities for Saskatchewan people, improving our quality of life, and delivering responsive and responsible government. The strategies in 2012-2013 for AEEI are:

- Improving employment and education outcomes for First Nations and Métis peoples;
- Ensuring post-secondary education remains accessible and affordable through new initiatives for students and families:
- Investing in programs and services that most effectively meet the needs of people with barriers to employment;
- Providing strategic support for research and innovation initiatives;
- Supporting the successful settlement and integration of newcomers in our workplaces and communities; and
- Enhancing the effectiveness and efficiency of programs and services to ensure the best use of public funds."

On May 25, 2012, Premier Brad Wall announced the creation of the Ministry of the Economy and the SATCC reporting to the Minister of the Economy. The SATCC 2012-2013 Business Plan aligns with the provincial government's overall emphasis on the promotion of economic growth and the Ministry of the Economy's mission to advance economic growth through development of a skilled workforce. The 2012-2013 SATCC Business Plan is designed to meet the immediate and longer term needs of industry to support the growth of the provincial economy.

To meet the demands of the provincial labour market and to develop a skilled workforce to support the growth of Saskatchewan's economy, the SATCC must find ways to accommodate the number of apprentices in training.

The SATCC focuses funding and staff resources on three major priorities.

- 1. Meet increased training demands for registered apprentices and upgrading clients.
- 2. Examine internal processes and training opportunities to increase efficiencies and improve client services.
- 3. Support stakeholders to increase apprenticeship participation for:
  - youth;

- women in predominantly male trades;
- Aboriginal persons; and
- foreign trained workers.

The SATCC core operating activities are impacted by key factors such as the number of newly registered apprentices. The 2012-2013 Business Plan projections for key factors and operational activities are provided in the following chart which includes previous fiscal year comparators.

#### Risk Analysis

The SATCC identified the following as potential risks to Business Plan outcomes.

- Impact from apprenticeship registrations the 2011-2012 forecast for new apprentice registrations is 6.5% higher than the original 2011-2012 Business Plan estimate; the 2012-2013 estimate is increased by another 3%, resulting in a continued growth in demand for technical training and all other SATCC services.
- Demand for technical training and sufficient financial resources. The level of provincial funding for the SATCC impacts SATCC operations and the amount of technical training that can be purchased. Technical training costs continue to increase due to increased collective bargaining and material costs, as well as the increased demand for technical training. The SATCC has met the 10% revenue generation goal in the years ended 2005 to 2008. This percentage decreased to 9.2% in 2008-2009 and was 9.6% in 2009-2010. The 2012-2013 budget anticipates non-grant revenues of 18.1%. For further analysis, please see the section titled "Risks of Not Meeting Apprenticeship Technical Training Demand" on page 9.
- Apprenticeship technical training capacity technical training delivery is contracted
  to post-secondary institutions (Saskatchewan Institute of Applied Science and
  Technology [SIAST] and others). Training providers must have the capacity
  (facilities and qualified instructors) to deliver technical training to increased numbers
  of apprentices and the ability to sustain both human resource and physical plant
  capacity if apprentice numbers decline.
- Attracting, training, motivating and retaining SATCC staff The number of staff (both in-scope and out-of-scope) eligible for or approaching retirement continues to be a factor to be addressed. There is always significant competition for employees with the appropriate technical skills. The challenge for the SATCC is to position itself as an employer of choice.
- Current changes in the labour force mean that increased numbers of apprentices
  may come from populations that have not traditionally had high participation rates in
  apprenticeship (women, Aboriginal peoples, foreign trained workers, workers with
  special needs). It is necessary for both SATCC staff and employers to focus more
  attention on supporting these apprentices to succeed in training and employment.
- Employer commitment to apprenticeship and trade certification employers who
  register apprentices demonstrate commitment to train and certify to national industry
  standards. The challenge is to engage employers, no matter the size of their
  operation or location, to participate in the apprenticeship program as opposed to
  merely hiring certified journeypersons away from other employers. This participation
  is necessary even in periods of industry volatility. The SATCC continues to work

with employers through workplace consultations to promote apprenticeship and the mobility of skilled labour as the best options for industry.

- The quality of training received by foreign trained tradespeople and/or apprentices in their countries of origin. An ever greater reliance on international immigration to meet the demand for skilled tradespeople means that both the SATCC and SIAST need more resources on an ongoing basis to appropriately assess and recognize the credentials of foreign trained workers.
- Renewed economic strength in mining, energy and construction has driven much of the current growth in apprenticeship. There are considerable ongoing opportunities in these sectors. In the future, the SATCC must consider and address emerging sectors, such as high technology (industries ranging from computer hardware to pharmaceuticals), not currently served by the apprenticeship model.

#### **Risks of Not Meeting Apprenticeship Technical Training Demand**

There is a direct and negative impact to the provincial labour market and economy if the SATCC is not able to meet the current industry demand for technical training seats.

In its December 2011 analysis of apprenticeship technical requirements, the SATCC identified that the real demand for 2012-2013 technical training seats was 6,256, which translates to 513 courses and \$18,555,000. The demand analysis incorporates the number of apprentices eligible to continue to the next level of training, any apprentices who have met all the requirements for the next level of training but were unable to attend training due to insufficient training opportunities or other reasons and new apprentice registrations.

- The 2011-2014 Report on Labour Market Conditions for the Apprenticeship Trades in Saskatchewan (produced jointly by AEEI and SATCC) indicates the following.
  - In 2011, 31 skilled trades (89%) had labour shortages with 12 of them considered severe, including: boilermakers, bricklayers, construction craft labourers, electricians, hairstylists, ironworkers, machinists, motor vehicle body repairers, painters and decorators, powerline technicians, roofers, and sheet metal workers.
  - Looking forward, the number of skilled trades with labour shortages is expected to remain the same, but conditions are expected to worsen, with 21 skilled trades having severe shortages by 2014.
  - Resource-intensive activities in the oil and gas sector, mining sector (particularly potash mining) and major capital projects contributed to labour shortages in 2011. The continuation of these activities and future projects are expected to increase demand for the skilled trades, causing increased severity of labour shortages over the next three years.

- The Construction Sector Council (CSC) Construction Looking Forward: 2012-2020 Key Highlights, Saskatchewan forecasts Saskatchewan's construction labour demands between 2012 and 2020. The report describes "the peak of a steep climb over 10 years of growth. Since 2001, industry employment has expanded by 70%. These gains surpass the remarkable construction growth in Alberta and British Columbia over the same period. All this growth has placed a heavy burden on labour markets and recruiting, at times, has been difficult. This situation will persist for the next few years."
- The Decade Ahead: Labour Market Projections & Analysis for Canada's Oil and Gas Industry to 2020 (released March 2011 by the Petroleum Human Resources Council of Canada) projects the oil and gas industry will require between 1,500 and 6,600 workers more workers in Saskatchewan.
- Saskatchewan Mining Industry Hiring Requirements and Talent Availability
   Forecasts, 2011 (released in 2011 by the Mining Industry Human Resources Council
   of Canada), estimates hiring requirements in the Saskatchewan mining industry to
   be between 9,200 and 21,600 over the next decade.
- The annual number of apprentices and journeypersons the SATCC is able to train for the provincial labour market will be reduced while the labour market is expanding in those sectors that require the skilled trades.
- Apprentices who do not receive technical training:
  - are not able to progress through the levels of apprenticeship, causing a delay in achieving journeyperson certification; and
  - do not receive wage increases tied to progression through levels of apprenticeship – resulting in less tax revenue for the provincial government.
- Apprentices could seek opportunities in other provinces where they can receive technical training in a timely manner.
- Employers will find it more difficult to hire skilled tradespeople resulting in a
  negative impact to provincial business activity and potential new projects. Employers
  will be unable to bid on jobs when journeyperson or apprentice requirements can't
  be met; challenges in retaining employees when their careers can't advance
  because they are unable to take training or become a journeyperson.
- If upgrading and updating training is not provided to apprentices and journeypersons
  to keep their training current and up to date, there are negative consequences to the
  skill level of the Saskatchewan workforce.
- All the above points result in apprentices, employers and business people giving negative feedback to the provincial government.

- Postponing technical training compounds the problem of finding sufficient training dollars. When technical training is postponed, it results in pent up demand for future training and technical training costs will increase, which means the SATCC will require more dollars to purchase the same amount of training.
- Technical training providers may have to reduce staff which will mean less capacity for technical training providers to meet future training demand. Technical training providers already suffer from challenges to attract and retain staff. If layoffs occur, it will be to the new instructors, not the long serving and soon-to-retire. It would be less than productive to have classrooms sitting empty because of a lack of funding at a time when training demand is at its highest level.

In a letter dated June 18, 2012, the Minister of the Economy committed an additional \$1,764,000 in one-time funding to cover the unforeseen collective bargaining costs related to 2011-2012 technical training and to provide 200 additional training seats for 2012-2013.

### 2012-2013 Budget

#### Overview

The single largest component of the SATCC's operating expenses is apprenticeship technical training, at approximately 75.2% of expenditures. Technical training costs for 2012-2013 are based on the following assumptions:

- providing 6,300 technical training seats, 200 more than in 2011-2012(6,100).
- assumed 2% collective bargaining increase in 2012-2013 and
- increased training delivery costs based on notification from other training providers.

The overall 2012-2013 technical training costs are forecast to be 8.4% higher than the previous year's budget.

SATCC salaries represent approximately 16.4% of operating expenses. This budget includes salary increases estimated at 2% for CBA costs in 2012-2013. In the 2011-2012 budget, a vacancy rate of 10% was applied. For 2012-2013, a 7% vacancy rate is budgeted. There are no position changes included in the 2012-2013 business plan and salary budget. The SATCC's total staff complement remains at 73.54 full time equivalent (FTE) positions.

The 2012-2013 provincial budget provides the SATCC with a total grant of \$19,682,000. Other budgeted revenues include:

- Revenue generation from client fees (tuition fees based on available technical training seats) - \$4,341,600
- ATA administrative fees \$180,000
- Other revenue \$59,000

The SATCC is required to maintain a minimum cash surplus (per Commission Board Policy) of approximately \$500,000. The 2012-2013 Budget results in an expected balance of approximately \$524,700 for June 30, 2013. The SATCC is required to closely monitor revenues and expenditures and must manage operational and training demands within the resources available.

The SATCC budgeted expenditures for 2012-2013 include:

- Technical training costs \$18,899,800
- Salaries \$4,114,800
- Travel costs \$243,300
- Office supplies \$64,300
- Office furniture \$5,000

### **First Nations and Métis Apprentices**

Government has committed to eliminate persistent gaps in education and employment outcomes between non-Aboriginal people and First Nations and Métis people as a priority for the Province. In 2012-2013, government designated \$600,000 of existing apprenticeship funding to improving outcomes for First Nations and Métis apprentices.

At June 30, 2011, there were 1,272 self-declared, registered Aboriginal apprentices. SATCC provides technical training, training coordinator and field staff supports to individual Aboriginal apprentices for which the costs exceed the identified \$600,000.

#### **Apprenticeship Technical Training Schedule**

The SATCC monitors technical training needs closely and will adjust the apprenticeship technical training schedule as required. The costs to deliver technical training have increased by approximately 10% over the last three years as a result of Collective Bargaining Agreements and inflation. The demand for technical training has also increased by approximately 10% annually over the past few years. The 2012 -2013 provincial budget established the SATCC's provincial grant at 2011-2012 levels while providing the SATCC the opportunity to generate additional revenues through higher tuition fees. The additional one-time funding provided by the Minister of the Economy on June 18, 2012 will make a significant impact in meeting the technical training needs identified for 2012-2103.

The SATCC has cut its operational costs significantly in this budget to support the technical training required and continues to look for efficiencies in its operations.

A "Technical Training Seats Summary" on the following page shows the variances between the 2011-2012 and 2012-2013 apprenticeship technical training schedules.
