

INSTRUCTIONS FOR THE TRADE QUALIFIER APPLICATION

This Form 7 must be completed by non-apprentices with work experience in a designated trade in Saskatchewan wishing to obtain their certification. The processing of this application includes registration and assessment of trade experience.

1. All Trade Qualifiers (including International applicants for Hairstylist, Esthetician-Nail Technician and Esthetician-Skin Care Technician Trades) the processing fee is \$400.00 paid by cheque, money order or credit card.
 - Cheques are made payable to the Saskatchewan Apprenticeship and Trade Certification Commission or SATCC. (There will be a \$25.00 charge for NSF cheques. No post dated cheques are allowed.)
 - This processing fee is non-refundable.

Exception:

 - Domestic Trade Qualifier for Hairstylist, Esthetician-Nail Technician and Esthetician-Skin Care Technician Trades the processing fee is \$200.00.
2. Attach trade specific Form 6A for each place of employment currently and previously worked. Refer to the designated trades on our website www.saskapprenticeship.ca for the 6A and a list of requirements for each trade.
3. Attach any copies of trade specific transcripts, certificates or international credentials. Please note that credentials must be translated to English.
4. Mandatory Upgrading before attempting an examination for the following trades:
 - Insulator (Heat & Frost)
 - Powerline Technician
5. Voluntary Upgrading is available in the following trades for those interested:
 - Automotive Service Technician (online)
 - Boom Truck A and B Operator (classroom or online)
 - Carpenter (classroom or online)
 - Construction Craft Labourer (classroom)
 - Construction Electrician (classroom or online)
 - Cook (online)
 - Industrial Mechanic (Millwright) (online)
 - Mobile Crane Operator (classroom or online)
 - Plumber (online)
 - Scaffolder (distance delivery)
 - Sheet Metal Worker (online)
 - Welder (classroom)

After the assessment is complete, candidates will be notified by letter if they meet the minimum requirement to apply for examination or upgrading. The assessment letter will explain your options:

Examination: Form 2 – application for written examination \$125.

Upgrading (mandatory or voluntary): You will be asked to contact the upgrading coordinator to be placed on the appropriate wait list.
