SYA CHAMPION AWARD WINNERS

When Blair Simpson, Saskatchewan Youth Apprenticeship (SYA) Champion and principal of Pontiex School, speaks about how he helps his students meet their goals, his passion and dedication is apparent. As an SYA Champion for the past 15 years, Simpson recognizes the value the SYA program can bring to students who are exploring post-secondary career options.

Simpson says, "[SYA] is really valuable for students. It gives students a connection to the real world of work where they have an opportunity to take their careers on a little bit of a test drive. Parents really enjoy it as well. They realize that that's the connection between the school system and the work life to become a journeyperson."

SYA Champions are teachers and administrators who facilitate the SYA program across the province to high school students. Every year, the Saskatchewan Apprenticeship and Trade Certification Commission presents an award to SYA Champions who demonstrate an exceptional commitment to the SYA program.

In 2021, four SYA Champion Awards were presented to:

- Clarence Neault, Athabasca Denesuline Education Authority in Prince Albert;
- Paul Raycroft, Humboldt Collegiate Institute;
- Blair Simpson, Ponteix School; and,
- Kara Wilkinson, North Battleford Comprehensive High School.

As an SYA Champion, Simpson finds it rewarding making connections with his students and helping them explore post-secondary options. He says SYA allows him to connect with students. The students who do go into the trades they realize the value of the benefits from completing the SYA program. "Some of them come back [after graduation] and say thank you very much for putting me through that program."

The SYA program would not be as successful as it is without dedicated SYA Champions who are passionate about helping their students achieve their post-secondary goals. Simpson summarizes his experience as an SYA Champion by saying, "SYA is a great program that's been running for years

Dear Apprenticeship Partners:

I'm excited to announce our new, online self-service system, MyATC, will be live for clients on January 10, 2022. An information package will be mailed out mid-December to our active clients: apprentices; trade qualifiers; SYA participants; employers and SYA schools. Please keep an eye out for your package in the mail.

MyATC will provide faster and more efficient services for apprentices, tradespeople and employers across the province. Apprentices will be able to complete an application for registering as an apprentice, process fee payments, view training requirements, access training classes and exam results, and log workplace hours. Employers will be able to process payments, manage apprentices and journeypersons, approve an apprentice's hours and skills, and monitor apprentice training and work progress. We look forward to January and the launch of MyATC.

Congratulations to all our 2021 Apprenticeship Award winners! Announced on November 5, 2021, we celebrated the 32 Outstanding New Journeyperson award winners, as well as SATCC award winners in 13 other categories and the winners of 10 industry award categories. While we made the decision to cancel the in-person event due to the ongoing pandemic, we were still able to celebrate the winners virtually through our social media channels and on our website.

In this edition of Apprenticeship in Action, we profile the SYA Champion Award winners. The award is presented to the SYA Champions who have demonstrated an outstanding dedication to the SYA program and their students by helping them achieve their goals with the skilled trades.

The week of October 31 to November 7 was proclaimed as Skilled Trade and Technology week. This week raised awareness of career opportunities in the skilled trade and technology sectors. We also used this week as an opportunity to express our gratitude for skilled trade workers and the essential services they provide to our communities.

and I plan on running it for a long time as an educator in the school system."

Paul Raycroft, SYA Champion at Humboldt Collegiate Institute, recognizes the importance of supporting students as they pursue careers in the skilled trades. "A lot of students don't learn the best sitting at a desk and reading out of a book. A lot of students are more hands-on learners." For Raycroft, the SYA program provides opportunities for students to explore the skilled trades.

As the business and work exploration teacher, as well as a career and grad coach, Raycroft meets regularly with students to help them explore career goals. He also works in tandem with other teachers and helps them register their students in SYA.

Raycroft encourages students to take advantage of the SYA program. "SYA gives students opportunities in the classroom and outside of the classroom when they are thinking about what they do want to do in their lives," says Raycroft. "SYA is not just for our [Practical and Applied Arts] classes; SYA can work in virtually any class. All the skills learned in the trades are transferable."

Clarence Neault is the SYA Champion and Career and Guidance Coordinator for the Athabasca Denesuline Education Authority in Prince Albert, which serves schools in three Denesuline First Nation communities in northern Saskatchewan. He can attest to the value SYA brings to his students' education. He says we can't expect students to find their passion without having a hands-on experience. SYA helps students find a trade, find a passion and pursue it.

For Neault, the most rewarding aspect of being an SYA Champion is watching the students succeed and being able to support and promote the apprenticeship process. As a

journeyperson Food and Beverage Person, Neault can relate first hand and passes his experience in the industry on to his students.

Neault believes apprentices learn some of their most important lessons from journeyperson mentors. He says, "They have to put the time in to learn to become a professional. As they learn and go through apprenticeship, over the years they learn the value of training and giving back."

SATCC LAUNCHES NEW SELF-SERVICE SYSTEM - MYATC

Apprentices and employers have been asking for the ability to self-serve through the SATCC's biennial client satisfaction surveys and on January 10, 2022 that request becomes reality with the launch of MyATC. MyATC is a new, online system that provides faster and more efficient service for apprentices, tradespeople and employers across the province.

By using either a desktop computer or mobile device, MyATC provides convenient and immediate access to information anytime, anywhere. In addition to flexibility, MyATC allows:

- Apprentices to complete an application for registering as an apprentice, submit fee payments, view training requirements, access training classes and exam results, and log workplace hours;
- Journeypersons to approve an apprentice's hours and skills; and
- Employers to submit payments, manage apprentices and journeypersons, and monitor apprentice training and work progress.

MyATC is designed to be user-friendly and is like other online services clients currently use.

For new clients, the <u>SATCC website</u> will provide information on how to sign up and log in. Current clients will receive information via Canada Post on getting set up in the system. In addition, once logged in to MyATC, there will be help articles built into a system knowledge base to assist clients navigating the process.

Since MyATC provides clients with so many benefits, including access to information when it's convenient for

them, the expectation is that clients will use the system; however, SATCC staff will always be willing to walk someone through the process over the phone or in person at one of our offices.

Field Services staff will also still be making visits to employers and will be able to provide support or answer questions about MyATC if needed.

There will, of course, be exceptions made for clients who don't have internet access. SATCC staff will still be able to enter information into the system on behalf of clients if there is a significant obstacle preventing them from using the system.

The SATCC is proud to provide this new service to our clients and looks forward to continuing to build trusted relationships with apprentices, tradespeople and employers across the province.

Where do I log in to MyATC?

You will be able to login directly to MyATC from saskapprenticeship.ca beginning Monday, January 10. Click on the link in the upper right corner of your screen. When the MyATC login page pops up, choose the appropriate login box (Employer or Apprentice).

SASKATCHEWAN ANNOUNCES \$4.38 MILLION FOR SKILLS TRAINING PROGRAMS

On November 29, 2021 the Government of Saskatchewan announced the funding of approximately \$4.38 million for Saskatchewan Apprenticeship and Trade Certification Commission (SATCC) and several other training institutions to deliver skills training programs to help continuing to grow a skilled workforce in Saskatchewan.

This funding will allow these institutions to expand their skills training programs in the construction, welding, and health care sectors to help meet the labour needs of businesses. It also supports key actions of the Saskatchewan Growth Plan to ensure under-represented groups are enabled to participate in the economy.

"Saskatchewan is making significant investments in training our provincial workforce as we enter a period of strong growth coming out of the pandemic," Immigration and Career Training Minister Jeremy Harrison said. "This funding will prioritize training for individuals who are underrepresented in the workforce, it will promote a more diverse and inclusive workforce, and it will grow the number of skilled workers in high-demand occupations in communities across Saskatchewan "

Several of these new training opportunities will be targeted at Indigenous individuals and will be delivered through partnerships between training institutions and the communities. The expansion of the Tiny House Project is one such project, and will provide Indigenous apprentices with work experiences, while working towards their journeyperson certificates by building small, modular houses in their local communities.

The training will be funded through the Canada-Saskatchewan Labour Market Transfer Agreements and provided by the SATCC and several other training institutions. In addition to the Tiny House Project expansion, the skills programs include:

- Welding
- Health Care Aide/Continuing Care Aide
- Medical Lab Assistant
- **Electrical Applied Certificate**
- Steel Stud and Drywall
- Introduction to Scaffolding

HARMONIZATION

During the month of October, work continued behind the scenes on the Harmonization Initiative. Provinces and territories reviewed the implemented harmonization sequencing in the trades of Heavy Duty Equipment Technician, Truck and Transport Mechanic and Construction/Industrial Electrician.

Feedback was received by the end of October through mid-November. Additionally, in November, a virtual, pan-Canadian workshop commenced for Truck and Transport Mechanic. Results are pending by mid-December.

SKILLED TRADE AND TECHNOLOGY WEEK

Skilled Trade and Technology Week in Saskatchewan launched Sunday, October 31 and ran until Sunday, November 7. This week raises awareness of career opportunities in the skilled trade and technology sectors, and is jointly supported by the Saskatchewan Apprenticeship and Trade Certification Commission (SATCC) and Skills Canada Saskatchewan. It aligns with National Skilled Trade and Technology Week, organized by the national body, Skills/Compétences Canada.

"The Government of Saskatchewan is pleased to proclaim Skilled Trade and Technology Week in Saskatchewan," Immigration and Career Training Minister Jeremy Harrison said. "Careers in the skilled trade and technology sectors are rewarding. The people who pursue these pathways make valuable contributions to our province's economy. It's important for us to celebrate them, especially now. Workers in these sectors have provided essential services throughout the COVID-19 pandemic."

This year, Skills Canada Saskatchewan, in partnership with ChatterHigh, hosted an online quiz that tests students' knowledge of skilled trade and technology careers. Students could play to win prizes, all while learning more about their post-secondary options. The competition ran ran until Thursday, November 4.

Schools were also encouraged to recognize the week by inviting apprentices, journeypersons or other industry representatives to present to their students.

"This week gives us the chance to highlight the valuable services people in the skilled trade and technology sectors provide for the citizens of Saskatchewan," Skills Canada Saskatchewan Executive Director Colin Phippard said. "These sectors are full of knowledgeable, talented workers – we want students to understand that."

Teachers encouraged their students to register in the Saskatchewan Youth Apprenticeship (SYA) program, overseen by the SATCC. To learn more about apprenticeship and career opportunities in the skilled trades, students complete 12 challenges, including interviewing a journeyperson; researching and writing a report on a designated trade; and completing at least one day of on-the-job work experience. Students who register as apprentices in Saskatchewan within five years of completion receive significant benefits: 300 trade time hours and the waiver of their apprenticeship registration fee and Level 1 technical training tuition.



"This week gives us an additional opportunity to promote the benefits of apprenticeship and a career in the skilled trades," SATCC CEO Jeff Ritter said. "Not everyone wants to learn at a desk. Not everyone wants to work at a desk. Many people prefer learning through mentorship – which is what the apprenticeship model of training is based on. Many people want to be up and active during their workday; working with their hands and solving tangible problems."

COMPULSORY TRADES REGISTRATION POLICY CHANGE

Effective September 1, 2021, SATCC requires employers to register employees when they are initially hired into the compulsory trades.

A completed Employer Application for Registering an Apprentice Contract (Form 1) and Contract between an Apprentice and Employer (Form A) will be required by the employee's first day of employment in a compulsory trade.

If the employee is hired by a Joint Training Committee (JTC), the Form 1 and the contract between an Apprentice and the JTC (Form B) will be required by the employee's first day.

The \$200 fee to indenture will not be required at the time of registration, however, it will be required within six months of the registration date for those in compulsory

trades.

Registration marks the beginning of one-half of the number of hours in an apprenticeship year (approximately six months or 900 hours) an employee is permitted to work in a compulsory trade as outlined in *The Apprenticeship and Trade Certification Regulations, 2020* before becoming indentured.

This registration process change will give the SATCC the ability to effectively monitor the number of hours an employee is working in a compulsory trade before becoming indentured, and to ensure that all employees working in compulsory trades are either registered with the SATCC, indentured as an apprentice or a certified journeyperson.

2020-21 SATCC ANNUAL REPORT

The SATCC's 2020-21 Annual Report was tabled in the Legislative Assembly on November 2, 2021. The highlights are listed on page 7. The full report is <u>available on our website</u>.

SYA BENEFITS

Effective September 1, 2021, partial benefits will no longer be granted for partial completion of the Saskatchewan Youth Apprenticeship (SYA) program.

Previously, if a student completed only one or two levels of SYA, they were eligible to receive 100 or 200 hours of trade time respectively when applying for apprenticeship. As of September 1, 2021, these partial benefits will no longer be granted. Only students who complete the whole program will be eligible for benefits.

SATCC OFFICES NO LONGER ACCEPTING CASH

Effective Monday, November 22, the SATCC no longer accepts cash for any payments in any of our offices. The only office that was accepting cash was the Regina office. Clients will still be able to pay via credit card; debit card; cheque; and e-transfer if requested.

provincially 2019 GRADUATE OUTCOMES SURVEY

The Ministry of Advanced Education, in partnership with post-secondary institutions, the Ministry of Immigration and Career Training and the Saskatchewan Apprenticeship and Trades Certification Commission (SATCC), is conducting a survey of students who graduated from a Saskatchewan post-secondary education institution in 2019 (July 2019 to June 2020 for private vocational schools' graduates).

The purpose of the survey is to gather information about Saskatchewan graduates' perceptions and experiences. Information is collected based on the graduates' level of

satisfaction with their education, sources of financing for their education, level of education-related debt, pre-and post-graduation mobility, as well as their education and employment outcomes.

CAF NATIONAL LEADERSHIP DEVELOPMENT PROGRAM FOR WOMEN IN THE SKILLED TRADES

The Canadian Apprenticeship Forum (CAF-FCA) will launch a new program to empower skilled trades advocates at the next Supporting Women in Trades Conference taking place June 2-3, 2022, in St. John's NL.

The National Leadership Development Program for Women in the Skilled Trades is being developed in partnership with the Office to Advance Women Apprentices and will be available to all tradeswomen including Indigenous peoples, LGBTQ2S+ individuals, immigrants, persons with disabilities, and those from racialized groups. Participants will be guided by subject matter experts, learning effective strategies and gaining practical tips to empower them as leaders in their workplaces and the broader community.
