

## Boom Truck Operator B Proficiency Examination Breakdown

<b>Apprentice Requirements:</b>	2 years and 2000 hours
<b>Tradesperson Requirements:</b>	3 years and 3000 hours
<b>Practical Examination:</b>	No

A provincial examination is based on the National Occupational Analysis (NOA) for the trade. The NOA describes the skills and knowledge required to perform the duties of the trade. Each standard is divided into Major Work Activities (MWA), which are divided into Tasks, which are divided into Sub-tasks.

The provincial examination has a certain number of questions assigned to these sections. The number of questions are provided below. For more information, see the full National Occupational Analysis for this [trade](#). \*NOTE - To pass this examination, an overall mark of 70%, along with a mark of 70% or above in MWA C: Load Charts must be achieved.
